\***Cyber Discovery** is the application of a combination of *data discovery* and *legal discovery* approaches to enable the exploration of patterns, trends, and relationships within unstructured and structured data with the objective of uncovering *insight* and *intelligence* to proactively or reactively respond to cybersecurity-centric challenges. **Data Discovery** is the exploration of patterns and trends within unstructured data with the objective of uncovering insight and driving action. **Legal Discovery** is the process of identifying, preserving, collecting, processing, searching, reviewing, and producing electronically stored information that may be relevant to a civil, criminal, or regulatory matter.
