




The Total Number of Hart-Scott-Rodino Act Merger Transactions Reported During Each Month





The Total Number of Hart-Scott-Rodino Act Merger Transactions Reported During Each Month









The Total Number of Second Requests Issued by the FTC and DOJ During Each Fiscal Year




Number of HSR Act Second Requests - FTC

The Total Number of Second Requests Issued by the FTC During Each Fiscal Year




